NOTICE is hereby given pursuant to Section 108 and Section 110 of the Companies Act, 2013 ("Act") and other applicable provisions, if any, of the Act read with Rule 20 and Rule 22 of the Companies (Management and Administration) Rules, 2014 ("Rules"), as amended from time to time, Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (hereinafter referred to as the "SEBI Listing Regulations") and Secretarial Standard-2 on General Meetings issued by The Institute of Company Secretaries of India ('SS-2'), each as amended read with the General Circular No. 14/2020 dated April 8, 2020, General Circular No. 17/2020 dated April 13, 2020, General Circular No. 22/2020 dated June 15, 2020, General Circular No. 33/2020 dated September 28, 2020, General Circular No. 39/2020 dated December 31, 2020, General Circular No. 10/2021 dated June 23, 2021, General Circular No. 20/2021 dated December 08, 2021 and General Circular No. 3/ 2022 dated May 05 2022, General Circular No. 11/2022 dated December 28, 2022 and General Circular No. 09/2023 dated September 25, 2023 issued by the Ministry of Corporate Affairs ("MCA") (hereinafter collectively referred to as "MCA Circulars"), that the Resolutions appended below for seeking approval from the Members of the Company by means of Postal Ballot, only by way of remote e-voting process ('e-voting') ,being provided by the Company to all its Members to cast their votes electronically.

In compliance with the aforesaid MCA Circulars, this Postal Ballot Notice is being circulated only by electronic mode to those members whose name appear on the Register of Members/List of Beneficial Owners as on **November 16, 2024** being the **cut-off date** for the purpose and to those Members whose email addresses are registered with KFin Technologies Limited (KFin), the Company's Registrar and Share Transfer Agent or Depository Participants. The communication of assent or dissent of the Members would take place only through the remote e-voting system. Those members who have not registered their e-mail addresses are requested to register the same by following the procedure set out in the notes to this Postal Ballot Notice.

As required under the provisions of Sections 108, 110 and other applicable provisions, if any, of the Act and the rules as applicable in that regard and Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company is providing e-voting facility through National Securities Depository Limited (NSDL) and Central Depository Services (India) Limited (CDSL). Members are requested to read the instructions in the Notes in this Postal Ballot Notice so as to cast their vote electronically.

The Board of Directors of your Company at its meeting held on October 29 ,2024, has appointed N. Balachandran, Practicing Company Secretary, Chennai (Membership No. 5113 and CoP No. 3200) as the Scrutinizer to conduct the Postal Ballot through remote e-voting process in a fair and transparent manner.

The voting period begins on **Thursday**, **Nov 21**, **2024 (9.00 a.m.IST)** and ends on **Friday**, **Dec 20**, **2024 (5.00 p.m. IST)**. The Scrutinizer will submit the report to Mr. S. Sivaramakrishnan, Managing Director or Mr. Niranjan Chandrashekar, Company Secretary of the Company upon completion of the scrutiny of the votes cast through remote e-voting. The results of the Postal Ballot will be announced on or before 5.00 p.m. (IST) on Sunday, Dec 22, 2024.

EXPLANATORY STATEMENT FOR PASSING PURSUANT TO SECTION 102 OF THE COMPANIES ACT, 2013 IN RESPECT OF THE SPECIAL BUSINESS TO BE TRANSACTED:

The following Explanatory Statement pursuant to Section 102 of the Companies Act, 2013 read with the Companies (Management and Administration) Rules, 2014, sets out all the material facts relating to the items of special business mentioned in this Notice.

Item No. 1

APPROVAL TO RAISE CAPITAL BY WAY OF ISSUANCE OF EQUITY SHARES OR OTHER ELIGIBLE SECURITIES TO PUBLIC OR PRIVATE ON A PREFERENTIAL BASIS FOR AN AMOUNT NOT EXCEEDING INR 500 CRORES.

Considering the business requirements, the Company proposes to raise capital to the extent of INR 500 Crores (Five Hundred Crores) and the Board of Directors at its meeting held on October 29, 2024, had approved the aforesaid issuance of capital. The issue is envisaged through issue of equity shares on a preferential basis, by way of public or private placement(s) including but not limited to issue of ADR, GDR, bond issue(s) (Qualified Institutions Placement), Share warrants, Preference Shares (Cumulative or non-cumulative or redeemable) to eligible Investors, with or without premium and recommend the same for approval of the shareholders.

This resolution empowers the Board or any Committee(s) constituted/ to be constituted by the Board from time to time, to raise funds and will be helpful for embarking upon public issues/ private placement(s)/ issue of ADRs, GDRs, FCCBs, debentures, bond issue(s) (Qualified Institutions Placement), Share warrants, Preference Shares (cumulative or non-cumulative or redeemable) in future in order to mobilize funds. The Company requires additional funds to foray into bigger infrastructure projects like power plants, desalination plants, bridges, roads, etc. and other general corporate purpose as may be decided by the Board from time to time, in accordance with the applicable laws.

This enabling resolution is put forth before the members for their approval by way of Special Resolution. The resolution proposed may result in issue of shares of the Company to persons other than the members of the Company and hence the consent of members is being sought pursuant to the provisions of the Section 62 of the Companies Act, 2013. None of the Directors are interested in the resolution except to the extent of their respective shareholding in the Company.

(a) Particulars of the issuance of Securities:

In view of meeting funding requirements and growth objectives of the Company and its businesses, the Board of Directors at its Meeting held on October 29, 2024, approved raising further capital of the Company for an aggregate amount not exceeding INR 500 crores (Rupees Five Hundred Crores Only), inter alia,

through issue of equity shares on a preferential basis, by way of public or private placement(s) including but not limited to ADR, GDR, bond issue(s) (Qualified Institutions Placement), Share warrants, Preference Shares (Cumulative or non-cumulative or redeemable) or other Eligible Securities, defined under

Regulation 171(a) of the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended ("SEBI ICDR Regulations") ("Eligible Securities"), through a qualified institutions placement ("QIP") pursuant to Chapter VI of SEBI ICDR Regulations, and/or Preferential allotment contained in Chapter V of SEBI ICDR Regulations, and/or any combination thereof or any other method as may be permitted under applicable laws, in the course of domestic or international offerings, through issue of preliminary placement document, placement document and/or other permissible/requisite offer documents to any eligible investors ("Offering"). The Equity Shares are proposed to be listed on both the Stock Exchanges where the Equity Shares are listed and the allotment of Securities would be subject to regulatory approvals, if any.

(b) Amount of the Offering:

This special resolution enables the Board to issue Equity Shares for an aggregate amount not exceeding INR 500 crores (Rupees Five Hundred Crores) or its equivalent in any foreign currency.

(c) Relevant Date: The "Relevant Date" will be the date when the Board (including any Committee thereof) decides to open the Offering for subscription or any other date in accordance with applicable law.

(d) Object(s) of the issue:

The Company shall utilise the proceeds from the issue (after adjustment of expenses related to the issue, if any) ("Net Proceeds") to foray into bigger infrastructure projects like power plants, desalination plants, bridges, roads, etc. and other general corporate purpose as may be decided by the Board from time to time, in accordance with the applicable laws.

(e) Basis or justification of pricing

The issue of Equity Shares or other eligible securities may be consummated in one or more tranches, at such time or times, at such price, at a discount or premium to market price in such manner and on such terms and conditions as the Board may in its absolute discretion decide taking into consideration prevailing market conditions and other relevant factors and wherever necessary in consultation with the book running lead manager(s) and other agencies and subject to the SEBI ICDR Regulations and other applicable laws, regulations, rules and guidelines. The price at which Securities shall be allotted in the Offering shall not be less than the price determined in accordance with the SEBI ICDR Regulations, through either the book building mechanism (in case of a public offer) or any other prescribed formula, as the case maybe.

- **(f) Interest of promoter, directors and key managerial personnel**: If the envisaged issue is undertaken in terms of Chapter V & Chapter VI of SEBI ICDR Regulations, the Promoter, member of the Promoter, Persons Acting in Concert or directors and key managerial personnel of the Company will not subscribe to the QIP.
- (g) Schedule of the Offering: The detailed terms and conditions for the offering will be determined in consultation with the advisors, book running lead managers and underwriters and such other authority or authorities as may be required, considering the prevailing market conditions and other regulatory requirements for different kinds of issuances. The allotment of the Securities pursuant to the Offering shall

be completed within such period as prescribed under the SEBI ICDR Regulations. In the event a QIP is undertaken, the allotment shall be completed within 365 days from the date of this resolution.

(h) Change in control: There would be no change in control pursuant to the said QIP.

Other material terms:

- (i) The Equity Shares issued, if any, shall rank pari passu in all respects with the existing Equity Shares of the Company, including entitlement to dividend, if any.
- (j) As the Offering may result in the issue of Equity Shares or other securities of the Company to investors who may or may not be Members of the Company, consent of the Members is being sought pursuant to Sections 23, 42, 62(1)(c), 179 and other applicable provisions, if any, of the Companies Act, 2013 and any other law for the time being in force and being applicable and in terms of the provisions of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended. The Board accordingly recommends the special resolution as set out in Item No. 1 of this Notice for your approval.
- (k)None of the Directors or the key managerial personnel of the Company and/or their relatives are concerned or interested in the said resolution, other than to the extent of their shareholding in the Company. The Directors or key managerial personnel of the Company or their relatives may be deemed to be concerned or interested in the proposed resolution to the extent of Equity Shares that may be subscribed by the companies/ institutions in which they are Directors or members.

The members may note that further to the Audit Committee's recommendation and the Board's approval, the Company had appointed M/s. Swaminathan Sridharan & Co, Cost Accountants (M:35237) as a Cost Auditor for FY 23-24 & FY 24-25 for a remuneration of Rs 75,000/- (Rupees Seventy-Five Thousand Only) (Per Financial year) plus applicable taxes and out of pocket expenses. The Company was informed on the untimely demise of the Cost Auditor Mr. Sridhar, M/s. Swaminathan Sridharan & Co, Cost Accountants (M:35237) on 27th September 2024.

The Board has approved the appointment and remuneration of Mr. G. Sundaresan, Cost Accountant, Chennai (Membership No.: 11733) as the Cost Auditors to conduct the audit of the cost records of the Company for the financial year ending March 31, 2024 and March 31, 2025, for a remuneration of Rs 75,000/- (Rupees Seventy-Five Thousand Only) (Per Financial year) plus applicable taxes and out of pocket expenses.

In accordance with the provisions of Section 148 of the Act read with the Companies (Audit and Auditors) Rules, 2014, the remuneration payable to the Cost Auditors has to be ratified by the shareholders of the Company.


